Our portfolio is based on **customs tariffs** data, comprising international commodity and customs **nomenclatures** as well as **tariff measures** for a wide range of countries worldwide.

In addition, we procure content on **non-tariff measures** of various destination countries such as import procedures and formalities or certification requirements.

Our service offer is complemented with data content on rules of origin as well as on export control measures and international sanctioned party lists.

customs tariffs

Our nomenclature and tariff databases for more than 160 countries are editorially integrated and consolidated. They are updated regularly and featured by an outstanding depth of integration, also covering internal taxes and additional levies due at importation.

To comply with the actual demands of our customers and their different use cases, the data content on customs tariffs is offered in a clearly structured way and in form of separate modules which may be combined according to your needs.

Nomenclature modules contain the tariff items (i.e. commodity codes) and product descriptions in English and form the basis of the customs tariffs data. The English descriptions are carefully revised to achieve a common level of quality. The hierarchy of the nomenclatures is fully reflected with appropriate dash structures.

The modules contain the information necessary for a uniform classification of materials and products into the nomenclatures of different countries of production and destination, based on the current tariff items and the correct version of the Harmonized System (HS) and, as the case may be, regional nomenclatures.

In case of countries which apply different nomenclatures for import and export, the relevant **export nomenclatures** are available separately.

We also support the (semi-)automated reclassification of materials and products in the event of nomenclature changes and offer reclassification modules for every update, with structured information on newly added and removed tariff items.

Language modules may complement the English version, which is the basis of the nomenclature modules, with product descriptions in German or other languages such as, for instance, Chinese or Russian.

Customs tariff modules share a common basis with the nomenclature modules but, in addition to the tariff items and product descriptions, also contain the regular rates of duty of the destination countries.

Preferential tariff modules may supplement the customs tariff modules with preferential tariff rates for designated countries of origin and regional trade agreements.

Import taxation modules enhance the customs tariff modules with product-related rates for additional taxes, levies or fees becoming due at importation.

As the case may be, further **measure modules** may be available depending on the country or upon specific request. These modules correlate indications for e.g. procedures, documents, competent authorities or relevant legislation to the tariff lines.


With regard to updates, we offer the most flexible approach, reflecting the various use cases of the data content. Therefore, different update modules may be chosen.

sanctioned party lists

We have developed a special approach to sanctioned party list (SPL) data based on a multiplicity of sources and a combination of different best practice methods.

SPL data goes beyond export control as the relevant sanctions do not only affect export (or import), but also apply to domestic transactions. In larger sized and internationally operating organisations respectively, there is no alternative to a structured approach to these sanctions regimes. Such approach usually calls for the need of automated screening procedures based on topical and well-maintained data content. We support this need with continuously updated, highly differentiated and carefully administered SPL data.

In our modular approach, the relevant sanctioned party lists may be chosen depending on the location, applicable jurisdiction and international business relations and may be complemented by further lists when necessary. It should, however, be borne in mind that in the understanding of the US authorities, their sanctions may apply extraterritorially.

We continuously monitor and check all relevant SPL data sources. This monitoring is done at least every 24 hours. The corresponding actualisation process usually results in several updates per week and, as the case may be, on a daily basis, depending on the occurrence and frequency of amendments.

The table on the next page demonstrates the most relevant sanctioned party lists, thus forming the basis of our respective offer. If, however, you are interested in further lists not contained hereunder, please feel free to contact us.

Certain sanctioned party lists, such as the Consolidated List of the EU and the UN, the Swiss SECO List, as well as the US SDN and ISN List, comprise so-called programmes. Depending on the list, about 10, 20 or even more than 60 different individual programmes may be covered. Sometimes, these programmes are also referred to and counted as different lists. Following this logic, the SPL data offered represents a number of single lists in the three-digit range. However, the mere quantity of lists is not the decisive criterion, whilst it is most important to identify the SPL data actually relevant for the individual business processes of a company or organisation. Although a general rule for data content, especially in this field it is quality rather than quantity that matters.

export control

Compliance with applied export control measures of for instance the EU and the United States has become increasingly important. However, also further countries or territories have implemented and maintain corresponding measures. Even EU Member States may enact measures going beyond the common rules in the European Union. As with US sanctions, the US export control regulations may be applied extraterritorially.

To achieve the respective compliance, the classification of goods according to customs tariff nomenclatures is not sufficient, as export control commodity lists are based on differently structured nomenclatures comprising specific categories.

According to our modular approach we offer the most important international and national export control commodity lists. Depending on the covered products, these lists usually refer to either dual-use or military goods. Where officially published, we also provide correlations of these lists to customs tariff nomenclatures.

Besides general lists of dual-use or military items subject to export control and licensing requirements, (designated) products may also be stipulated in connection with embargoes against specific countries.

rules of origin

Our portfolio is complemented by data content on rules of origin (RoO) of regional trade agreements (RTAs).

RoO stipulate how preferential origin is obtained or conferred by working or processing under a regional trade agreement, i.e. free trade agreement (FTA) allowing for preferential customs tariffs at importation into the destination country. Especially the so-called list rules of the relevant origin protocols are a challenge for the implementation of corresponding duty saving processes, as they vary with the regional trade agreements.

Our data content supports both the availability of current list rule texts broken down to the single rules as well as the automated origin calculation based on logical components such as, for instance, added value or item shift rules. The textual expression of the rules, however, always complements the logical components to allow for textual reference when mandatory or deemed necessary. For the rule texts different language versions may be supported whilst the logical components are language independent.

Like for the other subjects of this catalogue, also our data content on rules of origin is constantly being enhanced and upgraded. We are glad to receive your requests on list rules for further countries or regions.
